Is SHEQ ready for 3 Main Underground Resumption?

......Mr Tshamala lets us know....



3 MAIN underground mining operations expected to enhance the product mix of the company have continued to gather impetus through the delivery of the continuous miner and other key machines. The Safety Health Environment Quality aspect of operations have been taken a notch further ahead of the strategic resumption of operations slated for 2017 year end.

Safety, Health and Environment officer for 3 Main, Mr Sylvester Tshamala, said among a raft of developments is the construction of a new refuge bay underground, a twin broom roof bolter, stone dusters, intrinsic communication systems, refresher courses, PROTO team revival, safety talks, first aid training, periodic pneumoconiosis surveillance, pre-warning alarms and continuous PPE supply.

"The construction of the refuse bay will be complete by the end of the year. This will enhance safety underground in case of an emergency while awaiting rescue. The new roof bolter has twin brooms which are effective and quicken opening of the mine area support within an hour before ground movement," said Mr Tshamala.





address coal dust explosion and communication systems are in place with direct Mr Beaven Jinga said the recently delivered links via intrinsically safe radio systems.



"We did not have pre-warning alarms on conveyors but now have them ahead of resuscitation of operations. Communication will be direct using radio links, they are intrinsically safe for fiery mines. We have also conducted refresher courses on the required jobs, exchange of ideas as well as benchmarking with other companies like Unki Mine," said Mr Tshamala.

"The water being pumped out of underground is currently compliant with the discharge permit and will continue to be monitored on a regular basis. We hold safety talks, sectional meetings which culminate to department meetings. In addition, safety instruments like the new multi- purpose gas detector," said Mr Tshamala.



As a parting shot, he called for buffer stocks for protective clothing. "On provision of PPE, it has improved but we can do better, we envisage a situation whereby we have buffer stocks at our disposal. This will go a long way in minimizing loss shift time"



He said stone dusters will dust walls and floors to Also speaking to Hwange Weekly on the same tour, new Technical Superintendent for 3 Main underground, machines are flame proof and consist sophisticated exhaust systems to ensure the emissions are underground and environmentally friendly.

> "The recently revived Mine rescue team will attend emergencies and disaster preparedness. Pneumoconiosis surveillance checks will be conducted every three years," said Mr Jinga.

> Mr Tshamala joined the Colliery in 1979 as a Progressional trainee before assuming the role of a learner miner. From 1983 he has held the roles of Overseer miner, underground production foreman before joining SHE section in 2006.

The new mine was forced to closed in 1930s during the global economic depression.

Opencast mining started in 1970 on experimental basis.

The company was rebranded from Wankie to Hwange Colliery Company Limited and is currently pushing a "recapitalization program" in efforts to boost production and once again cement its presence in the energy industry and a rapidly globalizing world.

HWANGE ON HIGH CHOLERA ALERT - Dr Zinyemba

....Shaking of hands, boiling water, washing hands before food consumption.....

MEDICAL Services division is on high alert following the recent cholera outbreak which has hit neighboring Lusaka, Zambia.

Noting the high traffic volumes on the Zimbabwe- Zambia route mainly characterized by haulage trucks passing through Hwange, company customers collecting coal and coke products as well as community members frequenting the northern border for different activities, Dr Charles Zinyemba has called for improvement of personal hygiene, vigilance and general cleanliness.

"The Hwange community is urged to be vigilant as we share a lot in common with the country Zambia. In addition to observing strict, health and hygiene standards, any suspicious diarrhea case (s) must be reported to the nearest health facility," said Dr Zinyemba.

Dr Zinyemba said it was important boil water, wash hands after visiting toilets, before fruit and raw food consumption.

"I encourage everyone to wash their hands thoroughly before eating, wash fruits and raw foods. The water treatment is currently not sufficient hence all concession dwellers must boil their drinking water. Where possible, shaking of hands if faced with the possibility of getting in touch with people who have contact with individuals from cholera affected areas should be avoided," said Zinyemba.



Team Vusani in the Gijima 2 Project is a focusing on Asset Management. First of all, we will start by defining Asset Management; it is a systematic process of developing, operating, maintaining, upgrading, and disposing of assets costeffectively. It targets the production value chain from the coal resource to crushed products, with the aim of sustainably optimising integrated equipment maintenance and production related activities. This means the involvement of various stakeholders like Production, Finance, Supply Chain, Safety, Human resources as well as suppliers is key for an improved and functional asset management system most importantly in

achieving the project objectives.

The main objectives of the Gijima 2 Asset Management Project are:-

- To restore critical mining equipment as well as key units in coal processing and conveyance plants
- Achieve 85% availability for plant and equipment
- 85% availability target is a world class benchmark which means HCCL asset management has to be of world class standard. Therefore, below are the action plans:-
- Formulate and implement HCCL physical Asset Management Strategy & Policy

Optimise running spares and components requirements

Improve the engineering structure by re-organising and resourcing the **Engineering Department with** right skills

Train maintenance teams relevant stakeholders in defect elimination , FMCA Maintenance Tactics, Work plan management, ISO5500 and Ellipse System

In line with Asset Management Life Cycle restore critical production mining equipment as well as coal processing and conveyance plants.

18 Dump Trucks

12 Front End loaders

3 Bull dozers

Restore ESC8 bunkering System

Improve availability and reliability on Mobile Crushing Plants and ESC line Conveyor Systems

Challenges

The action plans for the Asset Management project range from Compiled by M Mhlanga (Team literally zero cost to multi-million Leader) dollars activities. The strategy of the team is to quickly accomplish action plans that do not require funding while aggressively pursuing those that need funding which are slow moving on the other hand. The progress on availing additional mining capacity has been affected by limited funding and long lead times of delivery of spares particularly imported spares.

Poor spares and service delivery by suppliers has adversely some affected the progress of the project and such have been engaged via Supply Chain and office of ESM. Also the team has made headways in engaging alternative suppliers. However, the team is confident that Service Level Agreements will solve these procurement challenges.

Focus before day 50

The focus is to:-

Have capacitated the maintenance and stakeholders through training and implementation of the Asset Management system and related activities for improved maintenance practices

Optimising running spares and components

Restore mining equipment and key units at the Processing Plant and Coal

In conclusion, the team is confident that by 50 or earlier there will be a remarkable improvement in the number of fleet mining running, maintenance practices and increasing availabilities.
